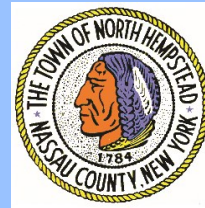

FAMILY: All residing at the same household, the head of the household and

1. the spouse/domestic partner of the head of household; and
2. the unmarried children of the head of household or the head of households' spouse or domestic partner, or any unmarried children for which the head of household or the head of household's spouse/domestic partner is the legal guardian; and
3. the parents of the head of household or the head of households' spouse or domestic partner.

DISABLED: Receiving social security disability benefits must show Medicare card or social security disability letter

VOLUNTEER: Firefighter, police, ambulance, must possess a volunteer ID card

NANNY: Must be accompanied with the child/no guests

Proof of Residency: official documents with current address and all 3 proofs are required for membership.

- 1) Property tax bill or deed - must show section, block and lot number; or if renting a current lease.
- 2) Current utility bill— gas, electric, water, cable or telephone.
- 3) Driver's license or Non-Driver's ID and birth certificates for all children

Library Card; Check; Expired ID; Nassau County Leisure Pass; Passport; Town or Village ID Cards will not be accepted as proof of residency!

Pass Renewal: must show **CURRENT UTILITY BILL & LICENSE**

19. No radios, stereos, CD players, mp3 players, or musical instruments shall be permitted. Only portable devices with headphones are permitted.
20. Food, candy, snacks, gum or beverages are permitted in the concession area only.
21. Alcohol is prohibited.
22. Glass and sharp objects are prohibited.
23. The town is not responsible for the loss, damage, or theft of private property of any patron.
24. Staff at the Aquatic Center are required to enforce and maintain all rules and regulations for your safety.
25. Passes may be revoked or entrance into the facility denied for failure to comply with sanitary and safety rules.
26. The supervisor of the pool may designate the maximum number of persons admitted in the pool enclosure consistent with public safety guidelines. The maximum number permitted in the pool and pool enclosure shall be posted in the pool area for the convenience of the patrons.
27. The Commissioner of Parks and Recreation may adopt additional rules and regulations that are found to be in the public interest and necessary for

WATER SLIDE RULES

- 1) Only one rider at a time. Absolutely no chain riding, stopping, standing, kneeling, or diving.
- 2) All riders must ride feet first while lying on their back. Do not sit up while riding the slide.
- 3) All riders must be at least 48" tall and under 300 pounds.
- 4) Obey all rules given by staff personnel.
- 5) No foreign objects are allowed in pockets and no jewelry can be worn while riding the slide. No exposed zippers, buckles, rivets or metal ornamentation can be worn; only approved swim suits allowed. No Sunglasses.
- 6) No tubes, mats, or life jackets are permitted on the water slide.
- 7) WARNING: Water depth is 3'6".
- 8) No person shall use the pool or water slide that, in the opinion of the lifeguard in charge is not capable due to age, skill, or physical condition.

RULES AND REGULATIONS GOVERNING THE USE OF THE AQUATIC ACTIVITIES CENTER

1. ONLY SWIM WHEN LIFEGUARDS ARE ON DUTY!
2. No admission to the Physical Activities Center without a pool membership card or proper identification and payment of fees.
3. Children 12 years or younger must be accompanied by an adult 18 years of age or older in bathing attire on the pool deck.
4. Children five years of age and older must utilize the locker room of their own gender. If the child needs assistance, family changing rooms are available.
5. Only persons dressed in proper bathing attire are permitted in the pool area. No street clothes, shoes, or sandals are allowed. (Aqua shoes are permitted)
6. Smoking and e-cigarettes are prohibited in the entire building.
7. No person shall use the pool or water slide that, in the opinion of the lifeguard in charge is not capable due to age, skill, or physical condition.
8. The use of cameras of any kind are not permitted on the pool deck, pool balcony or locker rooms.
9. Pool furniture shall not be moved or reserved.
10. Baby strollers are not permitted on the pool deck
11. No masks, swim fins, floating aids, kickboards, loose jewelry or snorkels are permitted.
12. Diving, running, ball playing, jumping, profane language, rough play, water guns and games are prohibited in the pool area.
13. Children who are not toilet trained must wear swim diapers with tight fitting plastic pants over the diaper.
14. You must be 16 years of age or older to use the sauna and steam room. A bathing suit or towel coverage are required in the sauna and steam room.
15. The following are strictly prohibited in the steam room and sauna: drying of clothes or towels, use of lotions or fragrances, exercising, drying off, and tampering with the heating units.
16. To use the exercise room patrons must be 16 years of age or older. Proper exercise attire must be worn at all times.
17. Any person having skin lesions, sore or inflamed eyes, mouth, nose or ear discharges, or carrying any communicable diseases, or persons having any type of bandage, adhesive tape, etc., is not permitted to use the pool.
18. Urinating, discharge of fecal matter, expectorating or blowing the nose in the pool is prohibited.

RESIDENT DAILY SINGLE ADMISSION FEES

YOU MUST SHOW PROPER IDENTIFICATION WHEN ENTERING. THERE ARE NO EXCEPTIONS. ALL GUESTS MUST BE ACCOMPANIED BY A RESIDENT. A RESIDENT WILL BE LIMITED TO 5 GUESTS PER HOUSEHOLD.
