

NOTICE OF HEARING

PLEASE TAKE NOTICE that a public hearing will be held by the Town Board of the Town of North Hempstead in the Town Hall, 220 Plandome Road, Manhasset New York, on the 21st day of October, 2014, at 7:30 o'clock in the evening for the purpose of considering the adoption of the following ordinance:

MANHASSET, NEW YORK

Section 1. All motor or other vehicles of any kind shall comply with the following regulation:

PROPOSAL:

1. T.O. 14-2014
Adopted September 9, 2014
THOMPSON SHORE ROAD – NORTH SIDE – NO PARKING ANY TIME –
From the west curb line of Buckingham Place, southwest, then west, for a distance of 294 feet.
2. T.O. 14-2014
Adopted September 9, 2014
THOMPSON SHORE ROAD – NORTH SIDE – NO PARKING, 10:00 A.M. TO 12:00 NOON, EXCEPT SATURDAY, SUNDAY AND HOLIDAYS –
From a point 294 feet southwest, then west, of the west curb line of Buckingham Place, west, for a distance of 783 feet.
3. T.O. 48-1966
Adopted June 28, 1966
THOMPSON SHORE ROAD – NORTH SIDE – NO PARKING ANYTIME –
From the east curb line of BAYVIEW AVENUE east to a point opposite the east curb line of VIRGINIA DRIVE.
4. T.O. 19-1969
Adopted April 15, 1969
THOMPSON SHORE ROAD – NO TRUCKS OVER 4 TONS GROSS –
From Bayview Avenue to Manhasset Avenue.

ADOPT:

1. THOMPSON SHORE ROAD – NORTH SIDE – NO PARKING ANY TIME –
From the west curb line of Buckingham Place, southwest, then west, then northwest, to the east curb line of Bayview Avenue.
2. THOMPSON SHORE ROAD – SOUTH SIDE – NO PARKING, 10:00 A.M. TO 2:00 P.M., EXCEPT SATURDAY, SUNDAY AND HOLIDAYS –
From a point where Thompson Shore Road meets Virginia Drive at its western end, east, to a point where Thompson Shore Road meets Virginia Drive at its eastern end.
3. THOMPSON SHORE ROAD – SOUTH SIDE – NO COMMERCIAL TRAFFIC EXCEPT LOCAL RESIDENTIAL DELIVERY –
From the east curb line of Bayview Avenue, east, to the south curb line of Manhasset Avenue.
4. THOMPSON SHORE ROAD – NORTH SIDE – NO COMMERCIAL TRAFFIC EXCEPT LOCAL RESIDENTIAL DELIVERY –
From the south curb line of Manhasset Avenue, west, to the east curb line of Bayview Avenue.

Section 2. All ordinances or regulations heretofore adopted in conflict with this ordinance are hereby repealed.

Section 3. PENALTIES: “A violation of this ordinance shall be punishable by a fine not in excess of Thirty (\$30.00) Dollars, plus any surcharge payable to other governmental entities.”

Section 4. This ordinance shall take effect ten days from the date of its publication and posting pursuant to Section 133 of the Town Law of the State of New York.

Section 5. This ordinance shall be incorporated in the Uniform Traffic Code of the Town of North Hempstead.
