SUPERVISOR BOSWORTH: Okay. Then we'll just get started. So tonight the Town Board will be voting on North Hempstead's 2022 proposed budget. We first submitted the Town's 2022

budget on September 30, and we held a work session on October 6, a public hearing on October 7, and a public hearing on October 21. Tonight we're voting on my administration's 8th budget. And we're doing this, maintaining my commitment and our town board's commitment to voting on the budget before Election Day. This year's budget once again continues the fiscally conservative practices of this administration, while continuing to deliver essential services to our residents. The \$156.6 million budget stays within New York State's tax cap. It includes 88.5 million for the general fund, 40.1 million for the town-outside-village fund, and 28 million in our town-operated special districts. The general fund tax levy increased by 2.9 percent, which is an average of \$9.20 per household. The town-outside-village fund increased by 2.3 percent. So homeowners in the unincorporated areas of the town will see an average increase of \$19.21 per household. Since taking office, we've consistently reduced debt. And Moody's Investor Service has now affirmed our town's AAA bond rating on 11 consecutive occasions. This rating is the highest rating a municipality can obtain. In its credit opinion, Moody's acknowledge that the stable outlook reflects the town's conservative fiscal management practices, which will support continued healthy operating performance and maintain a strong financial position. This year's budget is a product of our administration's planning efforts. And it takes into account analysis, suggestions, and reactions by the public. Our town council members have throughout the budget process been working with our finance staff to get input and to ask questions. I thank all of you for your hard work and commitment to our town and its residents. I'd also like to acknowledge the incredible efforts of our comptroller, Tania Orenstein; our budget team, including Hilary Grossman, Sharon Glassman, Diana Long; our director of finance, Steve Pollack; and my chief of staff, Jeanine Dillon. So many thanks to all of the commissioners and department heads who have worked hard to continue to serve our residents, while working with a tight budget. We have confidence in this budget and look forward to continuing to serve our residents. Thank you. So Mr. Wink, I'm going to ask that you please strike Item No. 1. The public hearing on this matter was held and closed on October 20. So thank you. And if you could, please begin tonight's agenda.


