(Whereupon, there were three minutes of public comments.)

CLERK SRIVASTAVA: I'm going with the item.

SUPERVISOR DESENA: Yes.

CLERK SRIVASTAVA: Item number one. A public hearing to consider the rescission and adoption of ordinances affecting Carle Road in Carle Place, New York.

SUPERVISOR DESENA: Councilman Troiano, would you --

COUNCILMAN TROIANO: Do we have any cards?

CLERK SRIVASTAVA: Pete Gaffney?

MR. GAFFNEY: Basically, I'm glad that you're putting parking signs over there and that's what this agenda item is about. Once again, there's no enforcement, so people are gonna park wherever the hell they want. Okay. You know, one of the conditions for Amazon on Westbury Avenue was that they don't bring their trunks or vehicles in on Westbury Avenue. They're doing it all the time now. Okay. Maybe that's the reason why six people moved out in the past

two years. They're not coming down Voice Road. Voice Road, somebody took off No Parking signs, so now they're parking on the side where you're supposed to be making a left turn. That big truck, the Stratocaster that Strata-Liner, excuse me. It's still back there. Okay. We have truck now in the back of TJ Maxx mall. I don't know if he's renting it out, or if that they're just doing it. There was one trailer that was there literally for four days. I was thinking maybe it was just dumped. There's are all the things that are happening, and they're all affecting the quality of life. Thank you.

SUPERVISOR DESENA: Thank you.

COUNCILMAN TROIANO: Anyone else like to be heard? Okay. This resolution would — I should of said this earlier, but this resolution would restrict parking for three — I'm sorry, that are currently being used by three people on Carle Road. The entirety of Carle Road has restricted parking. It looks as though that the three people that are parking there, either work down the street or park there just so they can go to the train station. It creates a safety hazard because they're blocking people's ability to, they're making a turn onto Carle Road ability to view, to see cars coming in a different direction. The neighbors have been surveyed about this, and they are in agreement. Since there are no more other comments and we've only had one positive comment, I offer the resolution and move for its adoption.

Section I. All motor or other vehicles of any kind shall comply with the following regulations:

CARLE ROAD – WEST SIDE – NO PARKING - 8:00 A.M. TO 4:00 P.M. – EXCEPT SATURDAYS, SUNDAYS AND HOLIDAYS

From a point 25 feet north of the north curb line of Mineola Avenue, north, for a distance of 80 feet.

ADOPT:

1. CARLE ROAD – WEST SIDE – NO PARKING - 8:00 A.M. TO 4:00 P.M. – EXCEPT SATURDAYS, SUNDAYS AND HOLIDAYS

From a point 25 feet north of the north curb line of Mineola Avenue, north, for a distance of 175 feet.

2. CARLE ROAD – WEST SIDE- NO STOPPING HERE TO CORNER

From the north curblines of Broadway, north for a distance of 30 feet.

Section 2. All ordinances or regulations heretofore adopted in conflict with this ordinance are hereby repealed.

Section 3. PENALTIES: “A violation of this ordinance shall be punishable by a fine, or when applicable, by imprisonment, not in the excess of the amount set forth in the Vehicle and Traffic Law of the State of New York, or by both such fine and

imprisonment, plus any surcharge payable to other governmental entities, and late payment, if applicable.

Section 4. This ordinance shall take effect ten days from the date of its publication and posting pursuant to Section 133 of the Town Law of the State of New York.

Section 5. This ordinance shall be incorporated in the Uniform Traffic Code of the Town of North Hempstead.






