WHEREAS, the Town of North Hempstead Solid Waste Management Authority (the "Authority") solicited bids for the Authority's Electrical Facility Upgrades at the Town of North Hempstead Landfills, SWMA Project No. SWMA-0010-2021 (the "Project"); and

WHEREAS, bids in response to the solicitation (the "Bids") were received and were opened, which Bids are as follows; and

Corporation, 79 Rocklyn Avenue, Lynbrook, NY 11563 (the "Contractor") as the lowest responsible bidder at its bid price of Three
Hundred Nineteen Thousand Eight Hundred Seventeen and 00/100 Dollars (\$319,817.00), which amount does not include alternative
work described in Plans Sheet E101 Note 16, as finally adjusted, if necessary, in accordance with the provisions of the contract; and

WHEREAS, in the event that the alternative work described in Plans Sheet E101 Note 16 is deemed necessary by the Executive Director and the Engineer and the Contractor performs such work, the "Executive Director") has recommended that the additional sum of Forty Thousand Five Hundred and 00/100 Dollars (\$40,500.00) be included in the contract and paid to the Contractor, as finally adjusted, if necessary, in accordance with the provisions of the contract; and

WHEREAS, the Town Board desires to authorize the award of a contract to the Contractor as recommended by the Executive Director.

NOW, THEREFORE, BE IT

RESOLVED that a Contract for the Project is hereby awarded to the Contractor, as the lowest responsible bidder, at its bid price of Three Hundred Nineteen Thousand Eight Hundred Seventeen and 00/100 Dollars (\$319,817.00), which amount does not include alternative work described in Plans Sheet E101 Note 16, as more particularly set forth in an agreement which will be filed in the offices of the Authority (the "Award"); and be it further

RESOLVED that the Chair of the Board of the Authority is hereby authorized to execute the contract documents, and to take such other action as may be necessary to effectuate the foregoing; and be it further

RESOLVED that the Office of the Town Attorney, as counsel to the Authority, is hereby authorized and directed to supervise the execution of the contract documents to effectuate the Award; and be it further

RESOLVED that the Comptroller is hereby authorized and directed to pay the cost thereof upon receipt of duly executed contract and certified claims therefor.
