WHEREAS, having examined the remaining bids, the Commissioner has recommended that the contract for the Project be awarded to Galvin Bros., Inc., 149 Steamboat Road, Great Neck, NY 11024 (the "Contractor") as the lowest responsible bidder at its total bid price of Four Million Eight Hundred Seventy-Two Thousand One Hundred Eighteen and 00/100 Dollars (\$4,872,118.00), inclusive of the Contractor's Total Gross Bid, Add Alternative 1 and Add Alternative 2; and

WHEREAS, the Town Board desires to authorize the award of a contract to the Contractor as recommended by the Commissioner.

NOW, THEREFORE, BE IT

RESOLVED that a Contract for the Project is hereby awarded to the Contractor, as the lowest responsible bidder, at its bid price of Four Million Eight Hundred Seventy-Two Thousand One Hundred Eighteen and 00/100 Dollars (\$4,872,118.00), as more particularly set forth in an agreement which will be filed in the Office of the Town Clerk (the "Award"); and be it further

RESOLVED that the Supervisor or her designee is hereby authorized and directed to execute the contract documents, and to take such other action as may be necessary to effectuate the foregoing; and be it further

RESOLVED that the Office of the Town Attorney is hereby authorized and directed to supervise the execution of the contract documents to effectuate the Award; and be it further

RESOLVED that the Comptroller is hereby authorized and directed to pay the cost thereof upon receipt of a duly executed contract and certified claims therefor.
