Note: §32-3. B. Permit placement.

"A Drop Off Bin Permit shall be affixed to every bin used by the Permittee for the collection and storage of new or used clothing, toys or other items, and the permit shall be affixed to the bin prior to placement of the bin. The permit shall be placed on the same side of the bin as the chute used for the deposit of the donated items. Upon the sale or transfer of the bin, a new permit shall be required and shall be affixed to the bin prior to placeng it in service.

C. The following information shall be conspicuously displayed on the exterior of the bin next to the permit in clear lettering no less than 3 inches in height nor more than 18 inches in height:

(*i*) The name, address and telephone number of the Registrant, and of any other entity which may share or profit from any clothing or other donations collected via the Drop Off Bin.

(ii) A statement indicating the manner in which the Registrant anticipates any clothing or other donations collected via the Drop Off Bin would be used, sold, or dispersed, and the method by which the proceeds of collected donations would be allocated or spent."
